

## 2025 Rhinoplasty Course

June 7-8, 2025

### Purpose

We will focus on basic rhinoplasty for the novice and will emphasize advanced topics. Special topics will include the use of fillers in rhinoplasty, adjunctive office-based maneuvers. Exhibitors will also be in attendance to demonstrate the latest in technology relevant to the practice of nasal surgery.

- 3 Enhance participants' ability to evaluate and manage complex rhinoplasty cases, including revision surgeries, while incorporating cultural, linguistic, and patient-centered care considerations for diverse patient populations.
