Course Description

This two-day conference for primary care providers and other health providers will integrate recent scientific data with current clinical practice regarding mood and anxiety disorders, substance misuse, personality disorders, collaborative care, pain psychiatric management, pandemic psychiatry, and how to do a primary care psychiatric interview.

Target Audience

Primary care physicians and allied health professionals interested in mental health.

Educational Needs

Primary care providers provide the most behavioral health care, and many have not been trained in the area of primary care based psychiatry. While guidelines for treatment of common psychiatric disorders within the primary care exist, many providers are uncomfortable implementing them due to perceptions of risk and stigma.

Learning Objectives

At the conclusion of this activity, the participant should be able to:

- Identify when it is appropriate to seek mental health consultation/referral
- Effectively screen for substance misuse
- Utilize motivational interviewing to assess readiness for change and activate motivated patients along the continuum of change behavior
- Identify evidence-based treatments available in primary care settings for substance use disorders
- Develop/adapt new models of care to integrate mental health care into primary care settings
- Effectively screen for depression in a primary care setting
- Engage mental health colleagues in collaborative care within existing models of healthcare delivery
- Implement evidence-informed treatment for depression

Robert McCarron, DO, completed a dual residency in internal medicine and psychiatry at Rush University and received board certification in psychiatry, psychosomatic medicine and internal medicine. Dr. McCarron is the Founding Director for the UC Irvine Train New Trainers (TNT) Primary Care Psychiatry (PCP) Fellowship and the TNT PC Training and Education in Addiction Medicine (PC-TEAM) Fellowship, which are one-year programs designed to train primary care providers in the essentials of adult psychiatry, pediatric psychiatry and SUD behavioral health. He is also Director of Education for the UCI Susan Samueli Integrative Health Institute. He serves on the ACGME Residency Review Committee for Psychiatry and is Medical Director for Mind OC. Dr. McCarron is a California National Alliance on Mental Illness (NAMI) Board Member.
