Presentation Overview

This course will provide information about maternal mental health (MMH), including risk factors, seven types of MMH conditions and substance use exposure. It will review local data using demographic identifiers to recognize populations at increased risk of MMH conditions. This course will also provide information on validated screening tools and referral pathways specific to Orange County.

At the end of the program, attendees should be able to:

- Identify five different diagnoses of MMH conditions.
- Identify three demographic identifiers that increase the risk of Orange County rates of postpartum depression.
- Describe three validated mental health screening tools for the perinatal population.
- Explain how the Plans of Safe Care can support members with substance use during pregnancy.
- Identify one appropriate referral pathway for individuals assessed with an increased risk of an MMH condition.
