Co-Chair, Right Care Initiative Heart Failure Work Group; Director, Pharmacy Performance, Memorial Care Foundation and Medical Groups

Dr. Giambrone currently serves as Director of Performance Improvement and Accountable Care Organization (ACO) Pharmacy Risk for the MemorialCare Medical Foundation. Her responsibilities include building and overseeing programs and processes related to managing ACO pharmacy risk and improving quality metric scores for employers and health plans. She has a long-standing interest in the management of Congestive Heart Failure (CHF) resulting from her professional and personal experience.



Nisha Parikh, MD, MPH

Clinical Associate Professor of Medicine; Clinical Cardiologist, Cardiovascular Care & Prevention Center, Pregnancy & Cardiac Treatment Program, University of California San Francisco

Dr. Parikh is a noninvasive cardiologist. She sees both men and women in her clinical practice, emphasizing primary and secondary cardiovascular disease prevention. She also has an interest in Women's cardiovascular diseases across the lifespan; including cardiovascular disease in pregnancy and the post partum period. Dr. Parikh is a trained cardiovascular epidemiologist and population scientist. She has added to the scientific knowledge base demonstrating which specific reproductive factors are predictors of cardiovascular disease using data from the NIH sponsored Women's Health Initiative Study and has leveraged data from the Swedish Population Registers. Her work has been supported by grants from the American Heart Association, the NIH/National Heart Lung and Blood Institute and the UCSF Preterm Birth Initiative. Dr. Parikh is the inaugural co-Chair of the UCSF Women in Cardiology Council, a group that promotes the recruitment and professional development of women in cardiology and encompasses 28 faculty and fellows at the three UCSF campuses. She has been an active volunteer for the American Heart Association (AHA) for over a decade. She currently serves on the AHA Board of Directors for the Bay Area and on the AHA Leadership Committee of the Epidemiology and Prevention Council (national level).



Christina Mijalski, MD, MPH

Clinical Assistant Professor, Neurology and Neurological Sciences, Stanford University Medical School; Director, Stanford

Dr. Christina Mijalski Sells joined the Stanford Stroke Center in 2016 and directs the Stanford Telestroke Program. Following her neurology residency at Brown University, she completed the Partners Vascular Neurology fellowship at Harvard Medical School. She also holds a Master of Public Health degree from the University of California, Los Angeles. Currently, her clinical and research interests include telemedicine, stroke in women, and healthcare delivery systems. Under Dr. Mijalski Sells' leadership, the Stanford telestroke program will extend the delivery of acute stroke care throughout the Bay Area.
